



GCCI arranged an Interactive web meeting with the Ahmedabad Police Department on 7th May, 2021 to discuss and find probable solutions for resolving the issues faced by Trade and Industry fraternity of Ahmedabad considering the COVID's second wave situation. Shri Sanjay Shrivastava, IPS, Commissioner of Police, Ahmedabad, Shri Prem Vir Singh, IPS Additional Commissioner of Police (Special & Crime Branch), Shri Rajendra Asari, DCP (West Ahmedabad), Shri Gautam Parmar, DCP (East Ahmedabad) and Shri Harshad Patel, DCP (Control Room) were present in the meeting. Shri Natubhai Patel, President GCCI gave brief information about relief work activities carried out by GCCI including the Oxygen bank and COVID isolation centre setup by GCCI for the Mild and Asymptomatic patients. Various issues faced by trade and industry were discussed in the meeting where GCCI Office Bearers as well as



representatives from 28 Associations participated. The issues related to Transportation, Movement of Goods, Administrative and Security related matters etc. were discussed and practical solutions to many of the concerns were obtained. 
Shri Pathik Patwari, Hon. Secretary GCCI, briefly highlighted relief activities done by GCCI and invited the Associations to put forward their issues.






An awareness session on Introduction of Dholera International Airport Project and Key Aspects of SIR - Dt. 22-06-2021

bring all Youth Wing Committees of all regional chambers across Gujarat closer.





Aspire Collaborative efforts with Start-up and Innovation Eco System with different committees of GCCI and relevant stakeholders.



Gujarat Student Start-up and Innovation Hub

Student Start-up and Innovation Policy (SSIP)

Gujarat has been at the forefront of working towards the Hon'ble Prime Minister's 'Start-up India' mission. To provide a thriving environment to empower and encourage its young innovators and entrepreneurs, the Education Department, Government of Gujarat has formulated and successfully implemented its iconic Student Start-up and Innovation Policy (SSIP) launched in 2017.

Gujarat is first among the states to create a Students Start-up and Innovation Policy (SSIP), to create an innovation and pre-incubation ecosystem support for students to develop an innovation and entrepreneurial culture in the state's universities and educational machinery and thereby create more young innovators, entrepreneurs and eventually, job creators. A student innovation fund of 200 crores for a period of five years has been created to execute. Building Innovation and Start-up Eco system is a long term endeavour and the Education department through Student Start-up and Innovation Policy (SSIP) is making persistent efforts for that. Through the policy financial support is extended to student innovators and start-ups along with students/alumni who have graduated/passed out from any college in Gujarat in the last 5 years.

Government of Gujarat is trying to develop a holistic Innovation Start-up Ecosystem involving all possible stakeholders. In the State Start-up Rankings, by DPIIT, Government of India, Gujarat emerged as the No. 1 state and was designated as a "best performing state". This is the second consecutive time that Gujarat has transpired as the start-up state in the country, retaining the pole position that the state had achieved when the rankings were announced by the Union government for the first time in 2018.

SSIP Achievements:

- 120 institutions and 48 Universities became SSIP grantees and extended support to students, Innovators & Start-ups.
- 4876 Teams have got financial support for developing proof of concept
- 1,700 early stage Start-ups got benefited
- 109 Pre-Incubation Centers have been developed



- 47 Fab labs have been developed across the state
- Around 9,21,332 students have been outreached through various initiatives.

Gujarat Student Start-up and Innovation Hub (*i*-Hub)

In an attempt to give further momentum to the Startup and Innovation wave in the state, Gujarat Student Start-up and Innovation Hub (i-Hub) is established as a flagship nodal agency, incorporated as a Section 8 company in May-2019. i-Hub is envisioned to be a centre for all start-up stakeholders to develop an endto-end innovation and entrepreneurial Eco system in the state of Gujarat by creating pathways from Mindto-Market.

The inclusive state-of-the-art centre will be the largest facility with cutting edge infrastructure for innovation and entrepreneurship with amalgamation of agile, flexible and collaborative co-working spaces to spark real interaction and flow of ideas and futuristic and advanced technology labs. The Hub leverages and channelizes this demographic advantage to build a vibrant ecosystem in the state.

Facilities at *i*-Hub

Co-working Space i-Hub offers a co-working space of approx. 20,000 sq ft to Start-ups which is well-equipped with basic amenities including high speed internet and can be readily used in plug-n-play model. A full-fledged new infrastructure of 1,50,000 sq ft is being developed that can house 500 Start-ups at once.

Networking Opportunities i-Hub has partnered with several Eco System enabling organizations which the Start-ups can leverage for their growth.

Infrastructural Support All the Start-ups are supported by providing access to the infrastructure support viz. meeting rooms, classrooms, conference room, library subject to availability which can be used free of cost or at minimum cost.

360° mentorship For guidance and mentorship, Startups have access to the mentor board of i-Hub consisting of eminent experts from various domain verticals like business modelling, UI/UX designing, product development, scale-up strategy etc.



IPR Support i-Hub provides patent and trademark support to Start-ups through our in-house State IP Facilitation Centre. All the expenses for filing patents and trademarks are reimbursed for the Start-ups associated with i-Hub.

Funding Assistance i-Hub provides financial assistance to Start-ups under various schemes. All the Start-ups have access to the capital support once they fulfil the eligibility criteria.

Flagship Initiatives of *i*-Hub

Several Flagship initiatives have been conceptualized at i-Hub. With an aim to scout, engage and leverage best mentors across domains and regions to help the Start-ups, i-Hub has come up with Start-up Sathi Flagship initiative. Under the same initiative, a '100 Webinar series' was successfully completed wherein, Eco System stakeholders across the country directly addressed the entire Gujarat Eco System which was broadcasted live for the larger benefit. More than 36 lakhs participants leveraged the '100 Webinar Series'. As of now, total 48 'Start-up Sathis' have been onboarded to mentor and guide Start-ups at i-Hub. A short-term mentoring program, Startup Engage, has been designed to address the problems faced by earlystage Start-ups in their journey and provide necessary guidance & networking by the mentors. Till now, 30 Start-ups have been mentored under this flagship program.

For the capacity building of various stakeholders of the start-up and innovation Eco System, **Start-up Saksham** was commenced. Under this, three capacity building programs were organized-a Comprehensive Online Course on Intellectual Property Rights (IPR) was organized which trained 5140 faculties; Nurturing Innovation and Start-up Eco System (NISE) trained 1410 stakeholders and 1402 innovators were trained Start-up Runway program. i-Hub launched and handheld 13 University Innovation & Start-up Centers & helped in establishing 15 University Intellectual Property Facilitation Centers at various universities in Gujarat till now.

For early and growth stage Start-ups, incubation space and allied facilities are provided by i-Hub under **Startup Grow** initiative. More than 100 Start-ups have been associated with i-Hub under the Start-up Grow program. Once the Start-up validates his/her idea, startups are given financial support of INR 2-25 lakhs to aid the expenses of Prototyping, under the Start-up Srujan initiative. A total of INR 1.24 Cr grant has been sanctioned to 40 Start-ups under this program.

Mind-to-Market initiative is to engage the students/innovators through an open innovation model in which they will co-create with various corporations for creating value. Total 21 innovators have been sanctioned under Mind-to-Market to work on their prototypes.

Start-up Samajh initiative is there to help the startups get various services like-IPR, funding, accounting, access to grants and allied auxiliary needs at a single point facility. After the Start-ups are ready with their prototypes/Minimal Viable Products (MVP) they can get a single-window interface to interact and co-create value with industry under the Start-up Square initiative of i-Hub. Access to R&D Labs, Testing Centers and expert organizations for certification to support Start-ups in the certification and validation process to help build better credibility for Innovators/Start-ups is covered under Startup Manak. i-Hub has also developed an e-commerce platform named Start-up Mart, exclusively for Start-ups to list their products resulting in collective push creating a better marketing opportunity for Start-ups.

State Intellectual Property Facilitation Centre (IPFC)

A dedicated state-level IP Facilitation Centre (IPFC) is set up at Gujarat Student Start-up and Innovation Hub (i-Hub) to create a single window IP support system. IPFC aims to facilitate students, Start-ups, innovators, researches and protect their IPRs by drafting applications for patent registration, copyrights, trademarks and industrial designs. It also assists innovators by providing support of experienced patent agents and tools which would make the IP filing processes easy.

Major services given by the IPFC are-overall IP Facilitation, capacity building of stakeholders, setting up of IPFC across universities, facilitate large scale IP literacy, promote IP based Start-ups, shape and implement IP support policy.

For domestic IP filing, innovators are supported with upto INR 50,000 and for filing IP in other countries or through PCT, support of upto INR 1,00,000 is provided.

In the concept stage an entrepreneur creates the minimum viable product and speaks to actual customers. Speaking to customers is the backbone of developing a good product. Then comes the commitment stage. In this stage the Entrepreneurs forms a company, develops the product and starts giving it to the client. Then come the validation stage. In this stage the startup is in the market and it demonstrates an increase in user base and growth in revenue. In this stage key performance indicators are also measured. Following this comes the scale up stage where addition of team, team building and capturing the market share takes place. Finally comes the establishment stage. In this stage there is consolidation of the market share and there is a potential exit happening throughout growing. A Start-up needs funds at various stages. 
