Important Points

Important points to be kept in mind by the applicant at the time of filling up the application form for GCCI Membership

- 1. The applicant should fill the form in clear and legible writing.
- 2. In case the office/ Factory/ Work address is provided by the applicant, it is compulsory to provide the proof of address.
- 3. In case the names of the representatives mentioned by the applicant are not included in the Memorandum of Association, then they need to provide a self attested copy of the Form 32 submitted to the Registrar of Companies notifying the names of the representatives.
- 4. In case of corporate members if the names of the representatives are not included either in the Memorandum of Association or in Form 32, the applicant has to submit a nomination letter on the Company's letterhead, duly certified by the authorized signatory/ Managing Director/ Chairman. (in case of listed company) or a board resolution (in case of unlisted company) as may be applicable.
- 5. Forms which are partly filled, or which do not include the cheque for the required amount, will not be accepted.
- 6. The Executive Committee reserves the right to cancel the membership of any member whose details are found to be incorrect at a later stage. The Executive Committee has the right to reject the application for membership without having to cite any reasons. Any applicant whose application has been rejected by the Executive Committee can reapply after a period of 2 years from the date of rejection of the application.
- 7. If the applicant resides in any area under the jurisdiction of the Ahmedabad District he would be classified under the local category. The applicant needs to provide such details along with the application form.
- 8. The applicant needs to submit along with the application form two passport sized/ stamp sized photographs of each representative, with names written at the back.
- 9. The applicant needs to submit details of whether the enrolment fee and annual fee has been paid from his own bank/ firm or company owned by him, in a covering letter signed by him.
