Eligibility for applying for the awards

- It is not mandatory for the firm to be currently a member of GCCI to be eligible for applying for the awards.
- GCCI Executive Committee members are not eligible to apply for the awards.
- The firm should be in continuous production in Gujarat for the last 5 years to qualify for the awards.
- The award is open for registered MSME Organizations only.
- The product manufactured by the Organizations should not be socially undesirable or a health hazard.
- The firm/company should be complying with the statutory laws of the State and the Country.

The awardees would receive a prestigious award along with a Citation from GCCI.

Last Date for receiving the applications is 15th February, 2018.
