Kindly accept warm greetings from GCCI.

We request reference to the captioned letter from your good office addressed to M/s Urja Products Pvt Ltd regarding Industrial GODOWN No.12 occupied by them at Odhav Industrial Area.

We understand from the said letter & also through our discussion with the representatives of M/s Urja Products Pvt Ltd that GIDC has levied them a charge of Rs.166,530/- towards **N.U.Penalty** + applicable GST.

In this regard, M/s Urja Products Pvt Ltd has already written to your office through their letter dated **September 11, 2018** that they have been using this facility to store their goods, however it doesn't reflect the use of electricity, since the facility is utilized during the day hours. The party is also in the process of relocating their factory from Odhav to Pirana and therefore they will soon be selling the godown.

From the above, it is apparent that the GODOWN is being utilized for the purpose for which it is meant i.e. storage of their goods and hence it is not proper to levy "N.U.Penalty" on them.

Respected Madam, you will appreciate the above stated facts & kindly do the needful to cancel the N.U.Penalty levied for the above.
