Sub: To remove Ban on PPE and fabric export.

Dear Madam,

Greetings from Gujarat Chamber of Commerce & Industry (GCCI).

Gujarat Chamber of Commerce & Industry [GCCI] founded in 1949, is the apex trade and industry body of Gujarat which works to create and sustain an environment conducive to the growth of industry and trade in Gujarat. With more than 4000 direct members including more than 200 regional chambers and associations of Gujarat, GCCI serves the interests of all sectors of trade & industry.

At present the Garment manufacturers wherever possible have switched over to safety manufacture garment like PPE which is made-up non-woven fabrics. As compared to domestics demand the quantity manufactured is much more and there is huge demand in export market for these items.

However, since Government has put a ban on PPE export and non-woven fabrics export, the huge surplus of finished goods cannot be exported. Primarily the ban imposed is with a view to ensure that the domestic demand is fulfilled, but the current situation is that the production is much more in excess of its domestic demand.

It is, therefore, proposed that the Govt. should remove restrictions on export of safety garments like PPE as also non-woven fabrics, which will help garment units and fabrics manufacturers unit to survive in tough time.
