2. Draft EIA Notification by MoEF&CC

3. Bank Guarantee / Heavy Penalty

We have represented several times about the Bank Guarantee and Heavy Penalty levied by GPCB even for smallest mistake by Industrial Unit in case of accident as per the guidance of NGT.

Looking to the present situation due to COVID-19, we humbly request that Bank Guarantee/heavy penalty must be imposed as per the category of MSME i.e. Micro/ Small / Medium / Large so that justification can be done to all the Industry accordingly.

The amount of Bank Guarantee and penalty must not be so much that Industry cannot bear the cost.

We would also like to discuss about the rectification of various circulars issued by the Board and discuss about reformation of various Committees of GPCB.

To discuss the above issues personally, we request you to kindly give us an appointment at your convenient date and time so that the issues can be solved amicably in the larger interest of MSME Industry.
