**PUBLIC NOTICE - "POLICY FOR DEVELOPMENT OF  
SMALL SCALE DISTRIBUTED SOLAR PROJECTS -2019"**

**Date – 09.08.2021**

This public notice is with reference to Government of Gujarat's "Policy for Development of Small Scale Distributed Solar Projects – 2019" notified vide G.R. No: SLR/11/2019/51/B1 dated 06.03.2019 read with Orders dated 08.08.2019 and 25.03.2021 passed by Gujarat Electricity Regulatory Commission in Petition No. 1802 / 2019 and 1954 / 2021, PPAs signed by DISCOMs with small scale distributed solar project developers at tariff of Rs 2.83/unit thereunder and GUVNL's earlier public notice dated 20.07.2021.

In this connection, it is to convey that a one time option to exit from the PPA (Exit option) shall be given to the developers who have signed PPAs with DISCOMs and charges recovered from developers who exercise such exit option shall be refunded as under.

- (1) Application fees of Rs 5 per KW collected by DISCOMs and GEDA each shall be refunded to the developers.
- (2) Liquidated Damages and Supervision Charges shall not be levied on the developers availing exit option. Accordingly, the Bank Guarantees as well as Provisional Supervision Charges paid by such developers shall be returned by DISCOMs.
- (3) Non-refundable connectivity charges of Rs 1,00,000/- per application levied as per GERC Regulations would be refunded after taking approval of GERC and based on the decision of GERC.

The developers willing to avail such one time option shall have to submit their written request in clear terms along with the prescribed undertaking to corporate office of Local DISCOM on or before 31.08.2021.
