## **REG :- MANAGEMENT OF GUJARAT PAVILION IN DEFEXPO-22**

With reference to our letter dtd. 05-02-2022 addressed to the Hon'ble Chief Minister, we have been orally communicated by your office that in principle we are required to manage the Gujarat Pavilion at DEFEXPO-22.

We are penning down the following points for clarification. We request you to kindly go through the same and confirm.

### ➤ **Scope of GCCI –**

- Erection of stalls, general decoration of hall including all carpeting etc. as per the layout mutually decided with your office;
- Marketing and allotment of stalls and bare space to exhibitors as per mutually decided rates with your office;
- General management of Gujarat Pavilion during Exhibition.

In a nutshell we shall be responsible for erection, marketing, selling & managing the exhibition space in the Gujarat Pavilion.

### ➤ **SCOPE OF INDUSTRIAL DEPARTMENT**

Allotment of pavilion in time & at free of cost. Support for marketing of exhibition space for large corporates and MSME as and when required.

### **We need to clarify the following points:**

#### **1. Registration charge of Rs.40000/- to be paid to MoD –**

- Whether registration charges has to be paid by the exhibitors, if yes please clarify the system for the same.
- Please suggest system if the registration has already been paid by some exhibitors.
- We request that Govt. of Gujarat to get a reduction in registration charges for Gujarat Participants or GOG should bear the same.
